## Terms and conditions of FSDC "My Career Miles" Membership Programme

FSDC "My Career Miles" ("MCM") Membership Programme is operated by the Financial Services Development Council (the FSDC) and governed by the following Terms and Conditions. By applying for FSDC "MCM" Membership Programme, you agree that you have read and understand these Terms and Conditions and agree to be bounded by the terms herein and as may be amended from time to time; you further agree to provide with the FSDC your personal data ("Personal Data", as defined in the Personal Data (Privacy) Ordinance (Cap. 486) of Hong Kong), and agree that the FSDC may collect and use your Personal Data in accordance with the Privacy Policy Statement.

## 1. Registration as "MCM" Member

- a. In order to be registered as a "MCM" Member, applicant must be tertiary student or young professionals who has graduated within 3 years. The registration process may require the applicant to provide the following information using the online registration form: name, mobile number, e-mail address (required in order to receive all eligible rewarded miles) and other personal information; and verify their e-mail address by receiving a verification code. A registered e-mail address serves as the unique identifier for this programme. One e-mail address can be registered as the "MCM" Member for one time.
- b. Data held by the FSDC relating to applications will be kept confidential. The FSDC may also refer suitable applicants to other vacancies within the Group. The personal data of the applicants may be disclosed to third parties involved in the Programme as required. All personal data of unsuccessful applicants will be destroyed after the registration exercise. For details of the ways in which we may use your personal data ("Personal Data"), please refer to our <u>Privacy Policy</u>.
- c. The applicant warrants and undertakes to the FSDC that all information provided to the FSDC in this membership application is complete, correct and not misleading, and agrees to promptly inform the FSDC in writing of any change in such information.

d. The applicant agrees to provide such supporting documents as the FSDC may reasonably require for the verification of the information provided herein and/or the processing of this membership application.

## 2. Membership Validity and Usage

- a. Once registered, applicant will receive a confirmation email regarding the application status within 48 hours. If applicant do not receive the confirmation email, please check "junk / spam mail" or email the FSDC TAP secretariat at tap@fsdc.org.hk.
- b. Please note that rewarded miles will only be calculated and rewarded miles to be accumulated after your registration as the "MCM" Member. No rewarded points will be calculated if you attend the TAP / Business events before the registration of "MCM" Membership Programme.
- c. Member's rewarded miles are valid from the date of successful registration, no miles will be carried forward after 12 consecutive months of the Member's registration All rewarded miles will automatically reset to zero after 12 consecutive months of the Member's successful registration.
- d. To earn rewarded miles from events, member must register and attend the TAP/Business events using the same registered e-mail address at the point of event registration. Rewarded miles will be automatically credited to member's MCM Account within 48 hours after your attendance, while the eligible record will be reflected on the FSDC's database after 48 hours of the event date. It may take longer for some third parity events. Please refer to respective terms and conditions for particular promotions. After an event record is completed, you can check your rewarded miles at the FSDC's website.
- e. Member whose accumulated miles reach the highest range of miles set by the FSDC within 12 consecutive months may earn an interview opportunity on the job shadowing or internship offered by the FSDC or other partnered financial institutions, subject to the final decision of respective hiring organisations. The details of redemption process and

interview opportunity will be announced at later stage. Member can visit the FSDC website for details.

- f. Once a job shadowing or internship redemption order is confirmed by a member, miles required for the redemption will be deducted from the member's account immediately, and the redemption order cannot be amended or cancelled.
- g. The rewarded miles do not carry any cash value and cannot be exchanged or redeemed in lieu of cash.
- h. The FSDC reserves the right to terminate Member's Account and/or Member's participation in the "MCM" Membership Programme if the FSDC determines in its sole discretion that the member has violated these terms and conditions, or that the use of the Member's Account is unauthorised, fraudulent or otherwise unlawful. The FSDC reserves the right to terminate, discontinue, modify or cancel the "MCM" Membership Programme or Member's Account at any time and in its sole discretion without notice to the member.
- i. The membership may be terminated by the applicant by giving no less than 14 days' prior written notice to the FSDC; and in any event, the membership shall be automatically terminated upon 3 years after the applicant's completion of his/her tertiary course or programme (as applicable) referred to in the member's application form, or the cessation of the member's status as a student of tertiary course or programme (as applicable), whichever the later. FSDC reserve the right not only to deduct rewarded miles from member's account but to take all actions which the FSDC considers to be

account but to take all actions which the FSDC considers to be appropriate if the FSDC suspects that such rewarded miles and event records were obtained via fraudulent, dishonest means or in such other manner not in accordance with these Terms and Conditions.

FSDC reserves the absolute right to amend the terms and conditions unilaterally and without the need to provide notice to its members prior to such amendments. In the event of any disputes relating to the usage of the membership and related matters, the FSDC shall have the sole and absolute right in the final determination of such matters.
