Eric Hui is the Chief Executive Officer of Zurich Insurance (Greater China) and the Chairman of Zurich General Insurance Company (China) Ltd., responsible for the general insurance business in Beijing, Shanghai and Guangzhou, and both general insurance and life insurance business in Hong Kong. With over 30 years in the insurance industry, Eric began his career at Swire Group in 1989 as a group management trainee, starting at the trading division and later specialized in insurance business. In his earlier roles with Zurich, Eric had led the expansion and development of SME and personal segments across Greater China and Southeast Asia and the wholesale business in Hong Kong before becoming responsible for the whole business portfolio of Hong Kong.

Eric chaired the Hong Kong Federation of Insurers (HKFI) for the office term of 2020/2021 before re-appointed as the Chairperson of the General Insurance Council (GIC) for 2024/2025. Currently he is serving as a Governing Committee member and the Chairperson of the Green Insurance Taskforce of HKFI.

Eric's current public positions include being the chairman of the Insurance Training Board of the Vocational Training Council, and a member of the Resolution Compensation Tribunal and Anti-Money Laundering and Counter-Terrorist Financing Review Tribunal as appointed by the HKSAR Government, Chairperson of the Motor Insurers' Bureau of Hong Kong, and Chairperson of the Advisory Committee of Employees' Compensation Insurance Residual Scheme Bureau Board. He is also the Deputy Chairperson of the Employees Compensation Insurer Insolvency Bureau, a member of the Belt and Road & Greater Bay Area Committee under the Hong Kong Trade Development Council, the Human Capital Committee under Financial Services Development Council, and the Insurance Management Committee of the Hong Kong Management Association. In the realm of academia and public welfare, Eric is a member of the Honorary Advisory Board for the Actuarial Society of Hong Kong, Global Advisory Board of MBA in Finance (FMBA) of The Chinese University of Hong Kong, and Board of Directors of The Jane Goodall Institute (Hong Kong).

Eric graduated from the Chinese University of Hong Kong with a master's degree and a bachelor's degree in business administration and completed the Advanced Management Program by INSEAD Business School, Fontainebleau. He holds the professional qualification of Associateship at the Chartered Insurance Institute, the Fellowship at the Life Management Institute and the membership of the Hong Kong Academy of Finance.

許先生於 2020/2021 年度出任香港保險業聯會主席，隨後被重新任命為聯會 2024/2025 年度一般保險委員會主席。現時，許先生同時擔任聯會的管治委員會成員以及綠色保險專責小組主席。

許先生現時擔任多項公職，包括獲香港特別行政區委任為處置補償審裁處及打擊洗錢及恐怖分子資金籌集覆核審裁處委員團成員、香港汽車保險局的主席，並為僱員補償聯保計劃管理局顧問委員會主席。許先生亦擔任保險公司（僱員補償）無力償債管理局之副主席、香港貿易發展局一帶一路及大灣區委員會成員、香港金融發展局人力資源小組成員，同時為香港管理專業協會保險管理委員會的委員。在學術界及公益方面，許先生現為香港精算學會名譽顧問會成員、香港中文大學金融財務 MBA 全球顧問委員會成員，並為珍古德協會（香港）的董事。

許先生畢業於香港中文大學工商管理碩士課程及工商管理學士企業管理學課程，及法國楓丹白露歐洲工商管理學院高級管理課程。他是英國特許保險學會會士、美國壽險管理學會壽險管理師及香港金融學院會員。
