周博士于2012年在香港理工大学管理及市场学系获得哲学博士学位。她负责教授和协调与金融科技，计算机伦理，商业智能，业务流程和工作流程管理以及业务和资讯系统战略相关的课程。周博士的研究兴趣包括资讯科技治理、金融科技应用、区块链及加密货币。并在国际期刊上发表了5篇论文，如战略信息系统期刊、工程技术管理期刊和应用专家系统。她曾担任多个国际期刊和会议的评论员，如MIS季刊和国际生产经济学期刊。

With over 8 years in this space, Dr. Chau is a seasoned FinTech professional with a strong reputation as being an industry and academic liaison.
